- 1. I have read the information material supplied with this application form which are downloaded from the website of the Bureau of Consular Affairs, Ministry of Foreign Affairs, [www.boca.gov.tw](http://www.boca.gov.tw), and fully understood and agreed to abide by the requirements on working holiday makers.
- 2. I understand that the primary intension of a working holiday maker is to holiday in Taiwan, R.O.C. and work is incidental to supplement the holiday fund.
- 3. If I am issued the visa, I will not undertake employment for more than 3 months with one employer or work for the full twelve months of the visit.
- 4. **I am aware that R.O.C.citizens ever registered with household in Taiwan shall be subject to the laws of the Republic of China while in its jurisdiction. ★According to the Regulations for Exit of Draftees Article 14 : For a draftee having maintained his household registation in Taiwan and has at the same time the status of double nationalities shall enter into and depart from Taiwan by presenting his ROC passport; any draftee entering into Taiwan by presenting a foreign passport and is duly subject to conscription shall be restricted from departing from Taiwan. - 5. **I am aware that drug trafficking is punishable by death according** to the criminal laws of the Republic of China.
