For minor applicant under the age of 18, please paste a parent's or a guardian's (the original guardianship certificate should be presented for verification) copy of the identification certificate and present the original for verification.

For applicants under 7 years of age and applicants under guardianship, please ask the legal representative to sign, such as OOO (mother's representative); for applicants who are over 18 years of age and unable to sign, please use fingerprints or seal instead of signature.
